

TERMS AND CONDITIONS FOR USING STATGRAPHICS® *ONLINE*

READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE USING STATGRAPHICS ONLINE. USE OF THE SOFTWARE INDICATES THAT YOU HAVE ACCEPTED THESE TERMS AND CONDITIONS.

1. Definitions. The STATGRAPHICS *Online* Application Software ("Software") described herein consists of the program code, web pages, data files, related user documentation and any enhancements provided by StatPoint, Inc. ("StatPoint"). Access to the Software is provided to you subject to the terms and conditions of this agreement ("Agreement"). To use the Software, you must have properly functioning supporting software (as specified in the documentation), installed on a computer ("Computer") upon which such supporting software will properly operate.

2. License to use. Licensee is granted a nonexclusive right to use the Software on one computer at a time in accordance with the terms and conditions of this Agreement, provided that Licensee: (i) does not modify the Software; (ii) does not redistribute the Software as part of any other product; (iii) does not charge anyone for use of the Software; (iv) does not remove or alter any proprietary legends or notices contained in the Software; and (v) agrees to indemnify, hold harmless, and defend StatPoint and its licensors from and against any claims or lawsuits, including attorneys' fees, that arise or result from the use of the Software.

3. Restrictions. Software is confidential copyrighted information of StatPoint Inc. and title to all copies is retained by StatPoint and/or its licensors. Licensee shall not decompile, disassemble, decrypt, extract, or otherwise reverse engineer Software. Software may not be leased, assigned, or sublicensed, in whole or in part. Software is not designed or intended for use in online control of aircraft, air traffic, aircraft navigation or aircraft communications; or in the design, construction, operation or maintenance of any nuclear facility. Licensee warrants that it will not use, redistribute, or permit the use of Software for such purposes.

4. Trademarks and Logos. This License does not authorize Licensee to use any StatPoint name, trademark or logo. Licensee agrees to: (i) not do anything harmful to or inconsistent with StatPoint's rights in its trademarks; and (ii) assist StatPoint in protecting those rights.

6. Limitation of Liability. STATPOINT SHALL IN NO EVENT BE LIABLE FOR ANY SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES, INCLUDING WITHOUT LIMITATION LOSS OF PROFIT, LOSS OF COMMISSIONS, LOST GOODWILL, IMPAIRMENT OF CREDIT, LOSS OF REPUTATION OR BREACH OF OTHER CONTRACT ARISING OUT OF THIS AGREEMENT OR ANY OTHER RELATIONSHIP OR ARRANGEMENT WITH LICENSEE. STATPOINT'S TOTAL LIABILITY FOR ALL CLAIMS (INCLUDING NEGLIGENCE) FROM LICENSEE SHALL NOT EXCEED, IN THE AGGREGATE, THE LESSER OF (A) \$5,000.00 OR (B) THE SUM OF FEES PAID BY LICENSEE TO STATPOINT OR ITS AGENTS UNDER THIS LICENSE.

7. Termination. This License shall automatically terminate on the termination date imbedded in the Software, if any. This License will terminate immediately without notice from StatPoint if Licensee fails to comply with any provision of this License. You may transfer your license to use Software only if the new licensee agrees to accept the terms and conditions of this Agreement, in which case your License shall immediately terminate. Any attempted transfer made without the new licensee's acceptance of the terms and conditions of this

Agreement shall be null and void. Licensee shall be liable to StatPoint for any and all damages attributable to an unauthorized transfer, including damages attributable to unauthorized use

8. Export Regulations. Software, including technical data, is subject to U.S. export control laws, including the U.S. Export Administration Act and its associated regulations, and may be subject to export or import regulations in other countries. Licensee agrees to comply strictly with all such regulations and acknowledges that it has the responsibility to obtain licenses to export, re-export, or import Software. 10. Governing Law. Any action related to this License will be governed by shall be construed and enforced under the laws of the State of New Jersey and the United States, notwithstanding any conflict of laws rules that might direct the laws of any other jurisdiction, and suit may be brought only in a court of competent jurisdiction in Virginia.

11. Entire Agreement. This Agreement constitutes the entire agreement between the parties with regard to the subject matter hereof.

12. Arbitration. Except as specified in this section, any dispute, controversy or claim arising out of or relating to the subject matter of this Agreement, or any breach thereof, including, without limitation, any claim that all or any part of this Agreement is invalid, illegal or otherwise avoidable or void, and including any dispute regarding the arbitrability of any dispute, shall be submitted to mandatory, binding arbitration in accordance with the Rules of the American Arbitration Association. However, no part of this Agreement shall be construed to limit any rights or remedies of STATPOINT at its sole option and discretion, to bring instead of or in addition to any arbitration under this Section, any action in any court of competent jurisdiction for injunctive or other provisional relief necessary or appropriate to protect any confidential information, copyright, patent, trademark, trade name or other intellectual property.

13. Severability. If any of the above provisions are held to be in violation of applicable law, void, or unenforceable in any jurisdiction, then such provisions are herewith waived or amended to the extent necessary for the License to be otherwise enforceable in such jurisdiction. However, if in StatPoint's opinion deletion or amendment of any provisions of the License by operation of this paragraph unreasonably compromises the rights or increase the liabilities of StatPoint or its licensors, StatPoint reserves the right to terminate the License.
